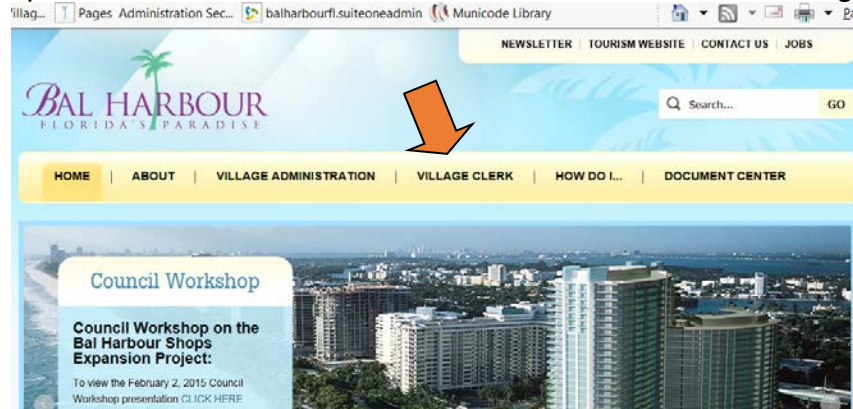

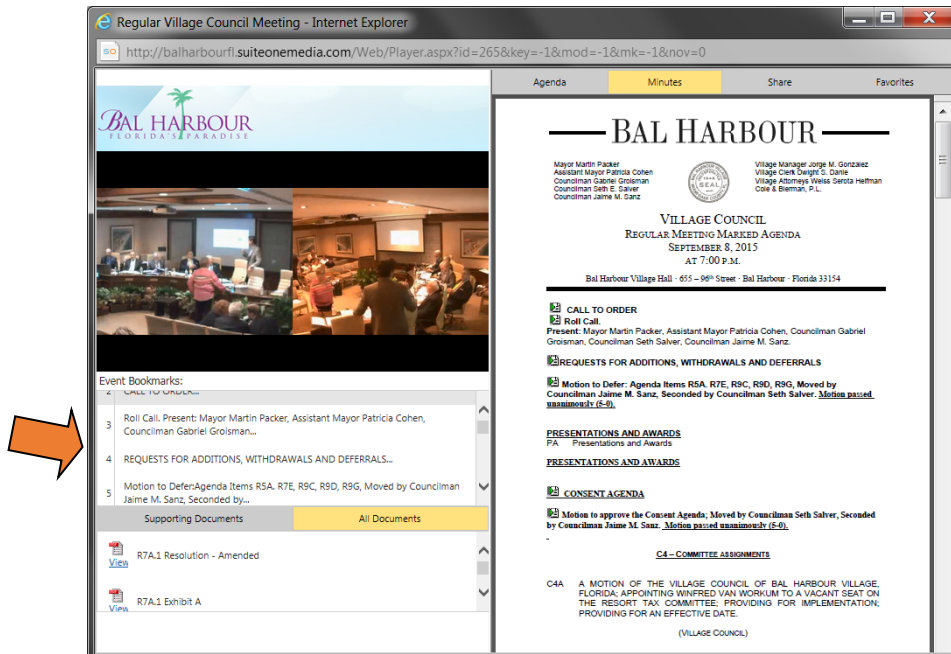
Miscellaneous
